



## **Plan ahead with these pre & post show tips!**

### **Prepare Ahead**

Exhibitors, make sure you leverage every aspect of the show. Use the venue as a way to meet potential new hires, dealers, and distributors, or set up times to meet with editors of trade magazines to discuss post show opportunities.

Another great way to maximize the show? Use it as a way to train new employees on new products and solutions so they can sell in the future!

### **Set Booth Guidelines**

It should go without saying but meet with your booth team to set rules for working the booth. There is nothing worse than spilling a coffee all over a prospect, so consider making your booth a no eating/drinking zone. You're at the show to conduct business, but attendees need to be valued for their time, so keep cell phone calls to a minimum.

Make sure to have your business cards or a QR code people can scan for more info.

### **Education First**

Almost as much can happen off the trade show floor as it does on it, if you leverage your "downtime" by attending as many educational programs, demonstrations and social events as you can.

Share your experiences and what you've learned with others. This can help build new relationships and strengthen existing ones. Invite everyone you meet off the floor to come see you at your booth.

### **Show Stopping Follow Up**

You might be surprised to hear something Salesforce found out when they surveyed trade show sales: 85% of leads aren't followed up after an event. ATS, Yankee's badge and registration company, offers badge scanning lead retrieval to all exhibitors to make getting contact info easy as pie! Now that you know who stopped by your booth, make sure to follow up! Better yet, pre-show, develop a follow-up plan for post-show!





### **Mass Mutual Center | 1277 Main Street | Springfield, MA**

**1. Set-up of Exhibits** – Exhibitors must register upon arrival and wear their registration badges/issued lanyards at all times. The show floor will be ready for occupancy at noon on Thursday, October 22, 2026. Setup hours are 12:00 noon to 5:00 p.m. on Thursday, October 22 and from 8:00 a.m. to 11:00 a.m. on Friday, October 23. Exhibitors will be allowed back into the Exhibit Hall 20 minutes before the show opens each day. Exhibit setup must be completed by 11:00 a.m. Friday. No exhibit set-up materials may be brought into the exhibition area while the show is open to attendees. Please see MassMutual Center material handling rules and load-in load-out procedures for specifics on the load-in process and associated cost.

**2. Exhibit Hours** – Ten hours of exhibition time are scheduled. Friday, October 23, 12:00 p.m. – 5:00 p.m.; Saturday, October 24, 11:00 a.m. – 4:00 p.m.

**3. Dismantling** – No exhibit material may be removed from the floor BEFORE 4:00 p.m. on Saturday, October 24. Please advise the Exhibitor Manager if you need to break-down your booth earlier than 4:00 for the comfort and enjoyment of all attendees and exhibitors. All material must be packed and shipped out of the area by 7:00 p.m. Saturday, October 24, 2026.

**4. Booth assignments** – Booth locations will be finalized approximately 6 weeks prior to show. All booths are as shown on the floor plan and dimensions are believed to be accurate but are only warranted to be approximate. Yankee Security Convention reserves the right the move/alter final floor plan to best accommodate all exhibitors fairly and comfortably.

**5. Furnishings & Decorations** – One draped 2' x 8' table, two chairs, booth carpeting, and a trash can will be furnished by the Yankee Security Convention, Inc. Any additional tables must be draped. The Show Decorator will provide Exhibitors with an Exhibitors Kit, via email, with information regarding rental of additional booth needs, i.e. electrical, additional tables, etc.

**6. Booth Equipment & Service** –The Yankee Security Convention will be furnished with a uniform booth set-up. To maintain uniformity and prevent obstruction of view of adjoining booths, displays must not be higher than 8 feet in back except that dividers may be built up beginning at the back of the booth and extending no further than 3 feet from the back without Exhibitor Manager Approval. No walls, partitions, decorations, or other obstructions may be erected which in any way interfere with the views of the other exhibitors. No materials and other booth furnishing may extend outside the 10'x10' booth and into the aisle. Booth side rails may be removed with approval from Yankee Security Convention Exhibition Manager's decision is final.

7. **Light/Power** – General lighting in the exhibition hall is furnished by the Convention, and the area will be well lighted. Additional/special electric needs will be available on order forms included in the Exhibitor's Kit.

8. **Booth Contents** – Exhibitor's materials must be non-flammable and conform with applicable fire laws and safety regulations. Materials of a dangerous nature are prohibited. Nothing may be attached to wall surface of the area.

9. **Signs** – A uniform name sign will be provided on each backdrop. Any additional signs will be at the discretion of the Convention Management.

10. **Aisle** – All aisle space is under the control of the Convention and shall not be used by the exhibitor for any purpose.

11. **Badges** – Each exhibitor will receive ID Badges that must be worn by all Booth Personnel for the duration of the show. All booth personnel should be registered online before the show. Attendee passes are not provided unless registered online as attendees prior to the show.

12. **Exhibits** – Exhibitors shall exhibit only within their designated areas and may not sublease any of their space without permission of the Show Management.

13. **Security** – Security guards will be provided by Mass Mutual Center for the exhibit hall. The Convention will not be responsible for or guarantee to the exhibitor the safety of exhibit materials against fire, accident, theft or loss or injury whatsoever. The exhibitor agrees to assume all liability which might ensue by reason of the exhibit and its presence at the exhibit. No merchandise may be removed from the exhibit area after being set up, until closing of the Convention at 4:00 p.m. on Saturday, October 24, 2026.

14. **Cleaning** – The Convention will arrange for cleaning the entire show floor area on Friday between 11am and 11:40. After that, each exhibitor will be responsible for cleaning his or her own booth area. The Convention will arrange for cleaning aisles.

15. **Insurance** – Yankee Security Convention, Inc. accepts no responsibility for the loss of, or damage to, any said material or displays. Exhibitors are to carry insurance on their exhibits at their own expense.

16. **Sound Effects, Loudspeakers, etc.** – Attention-getting devices, noisy equipment and audio-visual equipment will not be permitted except in locations where in the opinion of the Exhibition Manager such sounds and activity do not interfere with the activities of any exhibitor.

17. **Dangerous Products** – The exhibitor, on signing this contract, agrees to indemnify the Yankee Security Convention, Inc. from any claim or suit arising from the use or misuse of his or her products displayed in this exhibition, including reasonable attorney's fees or other costs of defense.

18. **Meetings** – Meetings of any type not sponsored by the Convention will not be permitted during the course of the Convention on October 22 through October 24, 2026, unless permission has been granted by Yankee Security Convention, Inc. specifically for such meetings.

19. **Conduct** – Exhibitors and their representatives are expected to conduct themselves in a manner that does not harass, intimidate or discriminate against any other exhibitor, attendee or member of the public at the venue hosting the convention. Yankee Security Convention Inc. reserve the right to take any action deemed necessary and appropriate, including immediate removal from the convention without warning or refund, in response to any incident of unacceptable behavior. This includes reserving the right to prohibit attendance at any future meeting.

20. **Cancellation of Exhibit Space** – Booth refunds will be as follows – Full refund if cancellation is received before September 1 st , 2026. 50% refund if cancellation is received between September 1st and October 1st, 2026. No refund for cancellations received October 2nd 2026 and later. All cancellations must be in writing to Exhibitors@yankeesecurity.org.

21. **Arbitration/Dispute** – Both Yankee Security Convention and exhibitor agree to submit any dispute of cause of action which may arise concerning the within agreement for any such dispute shall go through the Hartford Superior Court in Hartford, CT.

22. All Exhibit Material requiring shipment to and from the Convention must be consigned no sooner than 10 days before convention to Yankee Security Convention, through our Show Decorator Capital Convention Services. Details will be sent prior to the show. DO NOT SEND SHOW MATERIALS TO THE MASS MUTUAL CENTER. THE FACILITY WILL NOT ACCEPT and neither the FACILITY nor Yankee Security accepts any responsibility for the items. Materials will be delivered to your booth on Thursday for set-up.
